What is a Limited Service Pregnancy Center?

Limited Service Pregnancy Centers, also known as Crisis Pregnancy Centers, offer pregnancy tests, anti-abortion pregnancy and health care information, and sometimes ultrasound imaging.

They provide no medical care other than pregnancy tests and ultrasounds without medical diagnosis.

What is the Problem?

Women, often low-income women seeking free pregnancy tests, go to these centers in times of crisis, in need of medical care and unbiased pregnancy information. Instead, they get false or misleading information about what services are offered, their patient privacy is not protected, their test results and medical records are withheld, and they are denied needed referrals for reproductive health care.

Is there a LSPC near you?

There are at least 46 such centers operating in Washington State, in 21 counties and 33 legislative districts.

LSPC Accountability Act Solutions

WOMEN HAVE THE RIGHT TO KNOW WHAT KIND OF MEDICAL TREATMENT THEY CAN EXPECT WHEN THEY WALK IN THE DOOR.

Requires a limited service pregnancy center to **disclose** to a person seeking services that the center does not provide service or referrals for abortion or comprehensive birth control and that they do not provide medical care for pregnant women.

THE RIGHT TO KEEP MEDICAL INFORMATION PRIVATE

Requires the centers to protect the **privacy** of health care information collected from persons seeking services.

THE RIGHT TO MEDICAL TEST RESULTS

Requires centers to provide the tested person pregnancy **test results immediately**.
